DECLARATION OF INTEREST

There were no declarations of interest.

The minutes of the meeting held on the 5th June, 2017 were read, agreed and confirmed as a correct record.

MATTERS ARISING

<u>389/2014 Royston Hall Management Committee</u> – It was reported that a few alterations had been made to the draft management agreement and this has now been forwarded back to the Management Committee for their approval. The Management Committee had requested that before they took over the hall they would like the outside toilets emptied, cleaned and sealed. This work was carried out by Cllr Williams and thanks were expressed to Cllr Williams by the Community Councillors.

<u>393/2014 Powys Wellbeing Group</u> – Cllr Hughes reported that there was nothing further to report since the last meeting.

<u>452/2017 Lighting by Honey Café, Bronllys</u> – The Clerk reported that she had received correspondence from Leigh Williams, Street Lighting Operations Manager. He has indicated that senior managers of Powys County Council are apprehensive about installing the light at the moment because they may receive negative publicity for paying the energy and maintenance on a new street light when they have 2000 already switched off. They have asked if the Community Council would consider the following:

- 1. Paying for the energy and maintenance on the light energy would be £25 per year and the maintenance would be to electrically and structurally test the column every 6 years £20 and replace the photocell every 3 5 years roughly £35.
- 2. They are asking for the backing of our local County Councillor

Following discussion it was agreed that before a decision can be made on the above we need to know exactly where the light will be situated. The Clerk will contact Leigh Williams and ask him for a map.
