**MINUTES**

**MATTERS ARISING**

472/2017 Powys War Memorial Project – The Clerk reported that this work has now been completed.

473/2017 Speed Indicator Devices – Cllr Laurie-Parry reported that this remains ongoing.

486/2018 Play Area Pontywal Lane – The Clerk reported that there is no funding available. Cllr Laurie-Parry agreed to check if there is any spare regeneration funding.
