DECLARATION OF INTEREST

There were no declarations of interest expressed.

MINUTES

The minutes of the meeting held on the 6th February, 2023 were read, agreed and confirmed as a correct record. This was proposed by Cllr Doughty and seconded by Cllr Williams.

MATTERS ARISING

556/2020 Field Opposite Bronllys Garage – This remains ongoing.

580/2021 Rights of Way, Shrubbery Lane, Llyswen – This remains ongoing.

595/2022 Planning Application 21/1711/FUL – This remains ongoing.

604/2022 Charging Points for Electric Vehicles – This remains ongoing.

605/2022 Car Parking Royston Hall – Cllr Lewis reported that Mr. John Hopkins has spoken to the Hall Committee further regarding this. Both the Hall Committee and the Church have written letters of support.

607/2022 Grass Cutting, Llys Meillion – The Clerk reported that she has been assured by PAR Homes that the grass cutting and trimming of trees will be done by the end of March 2023.

609/2022 Bench for Llyswen – Cllr Hughes reported that the bench has been delivered and will be in situ in the near future.

610/2023 Parking, Bronllys Garage – The Clerk reported that she had heard nothing further from PCSO Jackson. The Councillors reported an overall improvement in the situation.

611/2023 Grass Cutting Tender – The Clerk reported that 4 tenders had been received as follows:

Following discussion it was agreed that Martin Leighton's quote of £2,500 be accepted.

612/2023 Resignation of Community Councillor – The Clerk reported that an election had not been requested and therefore an advertisement for Community Council for Wye ward had been advertised. If there are no applications by Friday 17th March co-option can take place.

613/2023 Shelves in Bus Shelter - Cllr Williams reported that he has asked Carl Selby to fit some extra shelves.

614/2023 Housing Development on Bronllys School Site – Cllr Colbert reported that there is currently an application submitted by the Bronllys Green Group relating to the area of land at the Bronllys CP School playing field and Neuadd Terrace play area which is under Commons Registration Act 1965 and Commons Act 2006 – Section 15 (1) Form 44 Application for the registration of land as a town or village green. Following discussion it was agreed that a meeting be arranged between the Bronllys Green Group and Community Council to ascertain what has been applied for in the first instance.

617/2023 Purchase of Bins for Llyswen and Bronllys – The Clerk reported that the bins have been ordered and are due to be delivered by the end of March 2023.

CORRESPONDENCE

A letter was received from Jonathan Southgate, Wye Knot Stop Café, Llyswen stating that “since the diversion recently put in place the village green opposite the pub and in front of the café has been run over by large lorries and other motors turn left up the hill (A470). This junction is often busy and we regularly have to repair the borders (stones, plant pots etc) but is now worse. I would like to replace the broken planters and border stones to both stop lorries driving over the green and improve the aspect of the centre of the village. However am happy for the council to do this themselves if they prefer. Please let me know what is the best option of either ignoring, repairing myself or repairing by the council. I just felt it important to highlight the increased level of traffic on this junction and how you recommend dealing with it”.

Following discussion as the Community Council are not responsible for this piece of land it was agreed that he should liaise with Powys County Council regarding this. The Clerk will contact with Mr. Southgate to this effect.
