DECLARATIONS OF INTEREST

MINUTES

The minutes of the meeting held on the 10th February, 2021 were read, agreed and confirmed as a correct record. This was proposed by Cllr Wormleighton and seconded by Cllr Hughes.

MATTERS ARISING

468/2018 Play Area Pontywal Lane – This remains ongoing.

501/2018 Bronllys School and Play Area – This remains ongoing.

550/2020 Dog Waste Bin, Moat Area, Bronllys – Cllr Williams reported that this has now been completed.

555/2020 Speed of Vehicles and Noise of Motorbikes in Llyswen – This remains ongoing.

556/2020 Field Opposite Bronllys Garage – This remains ongoing.

558/2020 Green Space, Llys Meillion – As Cllr Richards-Hill was not present there was nothing further to report on this.

559/2020 Lights, Bronllys Churchyard – Cllr Wormleighton reported that this remains ongoing.

560/2020 Resurfacing of Road, Bronllys – It was reported that this work has now been completed.

561/2020 Hedge, Court Farm, Bronllys – It was reported that this has now been completed.

562/2020 Housing Development Opposite Court Meadow, Bronllys – Cllr Lewis reported that JPL have removed the fencing but some has been put back. The signs have been removed but the work has not been completed with raised grates and that Powys are aware of the situation.

563/2021 Planning Application 20/1874/FUL – Bronllys Hall, Bronllys – The Clerk reported that she has heard nothing further regarding the Noise Management Report.

564/2021 Footpath, Haemorrhage Hill – Cllr Wormleighton reported that this remains ongoing.

565/2021 Communal Gardens, Llys Meillion – The Clerk reported that she had received communication from PAR Homes to say that this work should be completed in the next six weeks.

567/2021 Defibrillator, Bronllys – The Clerk reported that she has not heard from Nicki Credland with details of who can fit the cabinet properly. It was agreed that the Clerk chase this with Nicki Credland.

They would like to request funding this year once again from the Community Council.
