DECLARATION OF INTEREST

Cllr Laurie-Parry declared an interest, as County Councillor, in Planning Application 19/2035/RES: Application for reserved matters following the approval of P/2016/0793 for the erection of 30 dwellings and infrastructure; land at rear of Bronllys School, Bronllys.

MINUTES

The minutes of the meeting held on the 6th November, 2019 were read, agreed and confirmed as a correct record. This was proposed by Cllr Hughes and seconded by Cllr Lewis.

MATTERS ARISING

473/2017 Speed Indicator Devices – Cllr Laurie-Parry reported that she had written to Powys County Council regarding community infrastructure and has asked Ian Mills to cost out flashing lights stating “Slow Down and Actual Speed” in Llyswen. Cllr Lloyd asked if Cllr Laurie-Parry could enquire about having an average speed camera on each side of the village.

486/2018 Play Area Pontywal Lane – Cllr Page reported that she still had not heard from Stephen Butcher and would contact him by telephone.

495/2018 Defibrillator, Bronllys – The Clerk reported that the training had gone ahead but only 9 people attended. There was no charge made for the training but it was felt that it would be fitting to give a donation. It was proposed by Cllr Lewis and seconded by Cllr Hughes that a £50 donation be made.

501/2018 Bronllys School and Play Area – This remains ongoing.

521/2019 Brambles by River in Llyswen – This remains ongoing. Cllr Laurie-Parry and Cllr Lloyd will meet with Jenny Thomas from Powys County Council to put in an application for regeneration monies.

528/2019 Bus Shelter, Bronllys – It was reported that Carl Selby has had the noticeboard to erect in the bus shelter but the Clerk was not sure if the work had been carried out as yet. Cllr Page agreed to check on this. Cllr Lewis agreed to do a sign for the noticeboard.

529/2018 Street Lighting in Neuadd Terrace – Cllr Page has not yet been to see the residents in Neuadd Terrace but agreed to do so before the next meeting.

535/2019 Community Council Paperwork, Royston Hall – It was agreed that the removal of Community Council paperwork from the Royston Hall would be carried out in February.

It was agreed that the Clerk write to Mr. Hopkins thanking him for his kind offer of the field next to Royston Hall for a car park but that a decision would not be able to be made until a planning application had been submitted as as a public body Bronllys Community Council have to follow due process in all planning matters.

CORRESPONDENCE

A letter was received from Powys County Council asking for details of the Precept required for the 2020/21 financial year. Following discussion it was agreed that we apply for £12,000.

A letter was received from Josephine Rumsey, Clerk of Talgarth Town Council. Talgarth Town Council have purchased its own Speedwatch equipment, i.e. a speedgun, jackets, signs etc. and have 3 people trained up to undertake speedwatch sessions. They are asking if any of the Community Councillors from Bronllys wished to be trained up to be part of this scheme. Following discussion it was felt that we currently do not have the personnel to do this but will advertise it on the website. Cllr Page reported that she may know someone who would be interested and would ask them to contact Talgarth Town Council directly.
