**DECLARATION OF INTEREST**

There were no declarations of interest expressed.

**MINUTES**

The minutes of the meeting held on the 21<sup>st</sup> July, 2021 were read, agreed and confirmed as a correct record. This was proposed by Cllr S. Bouette and seconded by Cllr Lewis.

**MATTERS ARISING**

468/2018 Play Area Pontywal Lane – Cllr S. Bouette reported that she had met with Stephan Butcher from Powys County Council. Mr. Butcher has said that we can only apply for grants for the play area on Pontywal Lane. Following discussion it was felt that funding to the sum of £10,000 be sought for Pontywal Lane and that the £10,000 held by Powys County Council could be used for the Neuadd Terrace play area. However, before this can be agreed funding needs to be secured. Cllr Bouette will continue to complete application forms for grants on behalf of the Community Council and liaise with Stephan Butcher.

563/2021 Planning Application 20/1874/FUL – Bronllys Hall, Bronllys – As nothing further has been heard regarding this Cllr Lewis agreed to check on the Powys County Council website for any update before the next meeting.

### **ANY OTHER BUSINESS**

The Clerk reported that she had received a letter from Ms. Ani Lloyd resigning as Community Councillor for Llyswen Ward. Cllr S. Bouette reported that the piece of ground by the bus stop in the middle of the village is covered in moss and gets very slippery when wet. With the winter approaching it was agreed that the Clerk contact Boughrood depot to ask if the moss could be cleared.

Cllr Bouette reported that people are walking their dogs through the Neuadd Terrace play area and asked whether a "No Dogs" sign could be put up. It was agreed that Cllr Bouette contact Stephan Butcher regarding this as it is a Powys County Council play area.

Cllr Hughes reported that the new owners of the dwelling in Shrubbery Lane in Llyswen have purchased some extra land and have blocked off the rights of way and have put signs up saying "Private Property". As a result Lady Bingham, a resident of Llyswen, has challenged this with the Rights of Way Officer for Powys County Council. It transpires that this piece of land that has been used by adults and children alike for many years has never been registered with Powys County Council as a right of way. PCSO Emma Jackson has also received several complaints from residents regarding this and is looking to arrange a meeting with the landowner and community. Both Lady Bingham and PCSO Jackson were asking for the Community Council's support.

Following discussion it was felt that the Community Council needed to remain impartial at this point and that advice should be sought on how best to support a positive outcome for everyone from One Voice Wales. It was therefore agreed that the Clerk contact One Voice Wales for further advice.
