**DECLARATION OF INTEREST**

**MINUTES**

The minutes of the meeting held on the 6<sup>th</sup> January, 2020 were read, agreed and confirmed as a correct record. This was proposed by Cllr Hughes and seconded by Cllr Lloyd.

**MATTERS ARISING**

473/2017 Speed Indicator Devices – This remains ongoing. Cllr Laurie-Parry reported that she is in the process of getting prices.

486/2018 Play Area Pontywal Lane – This item is currently pending.

501/2018 Bronllys School and Play Area – This remains ongoing.

521/2019 Brambles by River in Llyswen – Cllr Laurie-Parry reported that she has received the application form for regeneration monies and will arrange to meet with Cllr Lloyd to complete the application.

528/2019 Bus Shelter, Bronllys – This remains ongoing.

529/2018 Street Lighting in Neuadd Terrace – Cllr Page reported that Powys County Council have stated that due to the issue on elderly people in the dark the street lamp B083 can be switched on but the Bronllys lighting bill must stay the same. Therefore, to switch the light on 3 or 4 lights around Bronllys must be switched to part-night (on dusk to 11p.m. and then 4.30 a.m. to dawn). There will also be a cost involved for a new head and LED bulb amounting to £250.00. Cllr Page proposed that we go ahead with this and this was seconded by Cllr Wormleighton. Cllr Laurie-Parry will give the numbers of the lights that can be switched to part-night to the Clerk to forward to Powys County Council along with a cheque for £250.00.
