MINUTES

MATTERS ARISING

<u>468/2018 Play Area Pontywal Lane and 501/2018 Bronllys School and Play Area</u> – The Clerk reported that she had spoken to Stephan Butcher and he had indicated that he was arranging for some steps to be put on the monkey bars in Neuadd Terrace and for some matting to be put in the Pontywal Lane play area.

556/2020 Field Opposite Bronllys Garage – This remains ongoing.

580/2021 Right of Way, Shrubbery Lane, Llyswen – This remains ongoing.

<u>585/2021 Bench, Llys Meillion</u> – Cllr Hughes reported that PAR Homes have put in a base but this will need to be moved as it is in the wrong position. Once this is done the Community Council will purchase a bench.

<u>590/2022</u> Speed of Vehicles through Bronllys – Cllr Lewis reported that he had received correspondence from the daughter of one of the residents in Watson Cottages who was nearly run over trying to cross the road from the Bronllys path up to Watson Cottages due to the speed of the

cars coming from Brecon down to the roundabout. It was agreed that the Clerk contact Powys County Council again to ask if a representative from Highways would be prepared to attend a site meeting with Community Councillors and residents of Watson Cottages to consider any measures that could be implemented to prevent injury/fatality to pedestrians.
