Planning Application Reference: 23/0928/REM. Proposal: Section 73 application to vary condition 26 iii (affordable housing condition) of planning approval P/2017/1178 (development of 14 dwellings) — Greenfield, Bronllys, LD3 0LE

Following discussion it was agreed that the following comments be submitted to Powys County Council:

"Bronllys Community Council are extremely disappointed that the houses in question will no longer be offered to a housing association and will be available to purchase on the open market at 72% of market value. On Right Move (22/07/23) there were 2 properties for sale at the following prices:

The Dawn View - £750,000 minus 72% of market value = £540,000

The Heartland - £550,000 minus 72% of market value = £396,000

We are at a loss to see that people seeking affordable housing would be able to afford these prices for the 2 properties above.

Bronllys Community Council would also echo the comment from Stephan Butcher, Countryside and Outdoor Recreation regarding the lack of play facilities and would request a Section 106 contribution for the play area which is owned and maintained by Bronllys Community Council.

Planning Application Reference 23/0971/FUL. Proposal: Siting of 2 no. Shepherd Huts (for holiday use), installation of new sewerage treatment plant, formation of access tracks and all associated works — Land at Church Road, Llyswen, LD3 OUU.

No objections were expressed.

<u>Planning Application Reference: 23/1145/HH. Proposal: Erection of an extension and porch – 4 Neuadd Terrace, Bronllys, LD3 0LA.</u>
