DELCARATION OF INTEREST

There were no declarations of interest expressed.

MATTERS ARISING

389/2014 Royston Hall Management Committee – The Clerk reported that she is yet to receive the template document from Powys County Council but will continue to chase this. The Management Committee have asked if the Community Council would fund a metal post box and key holder for the front of Royston Hall at a cost of approximately £70. This was agreed. Mrs. Emerson reported that they had a donation from the Black Mountains for flooring in the ante room and also requested a financial statement of utilities for the hall which the Clerk agreed to do. An E Mail had been received from Susan Jones from Powys County Council regarding the licence which is currently under the name of the Community Council and whether we wished to have it transferred to the newly formed Management Committee. Following discussion it was agreed that the licence be transferred to the Management Committee. The Clerk will inform Powys County Council regarding this.

In the first instance it was agreed that the Clerk contact Mr. Howland to ask if he would like to repair the seat but if not costings will be sought from Mr. Carl Selby.
