**MINUTES**

**MATTERS ARISING**

473/2017 Speed Indicator Devices – Cllr Laurie-Parry reported that she had met with Jo Lancey and they first need to establish whether there is a need for speed devices. If it is indicated there is a need they will put SID's in, but if not they are £3,000 each. Cllr Laurie-Parry agreed to look into funding for this.

## **ANY OTHER BUSINESS**

Cllr Wormleighton agreed to represent the Community Council. They are also looking for financial assistance to carry out a feasibility study and it was proposed by Cllr Hughes that we donate £200.00. This was seconded by Cllr Wormleighton and agreed by all present.

Cllr Hughes reported that there will be a litter pick in Llyswen on Saturday 14<sup>th</sup> March, 2020 starting at 9.30 a.m.

Cllr Page reported that the BACS group are looking to hold the following activities this year:

Cllr Page asked if the Community Council would be able to offer any financial assistance for the VE Day Celebrations and Cllr Lewis proposed £200.00 which was seconded by Cllr Hughes and agreed by all present.
