**DECLARATION OF INTEREST**

Cllr Mrs. Karen Laurie-Parry declared an interest in the two planning applications (under correspondence).

**MINUTES**

The minutes of the meeting held on the 13<sup>th</sup> October, 2021 were read, agreed and confirmed as a correct record. This was proposed by Cllr M. Bouette and seconded by Cllr Williams.

**MATTERS ARISING**

468/2018 Play Area Pontywal Lane – Cllr Laurie-Parry reported that she had written to the Chief Executive and Stephan Butcher re play equipment and monies available for Bronllys but she is yet to receive a reply. Cllr Lewis reported that Stephan Butcher had informed the Community Council that there was £10,000 available for Bronllys. Cllr S. Bouette reported that she had met with Stephan Butcher to discuss equipment available. She said that she had tried to get Covid grants but the grants available did not tick the correct boxes. Following discussion it was agreed that Cllr Lewis contact Stephan Butcher to get proposals of equipment and quotes sent out and if needed an extraordinary meeting could be held in December to discuss further.

3. She is writing to Powys County Council regarding the state of the walk for the residents from Ty Bronllys into Bronllys village.

Cllr Lewis reported that he had attended the Governors Meeting of Llyswen School and they have hit “a brick wall” with regard to crash barriers being installed on the large piece of land next to the school. The Welsh Government are refusing to install crash barriers which means that the large piece of land next to the school cannot be used due to the potential of a lorry/car crashing into the field. It was agreed that the Clerk write to the Welsh Government regarding this.
